

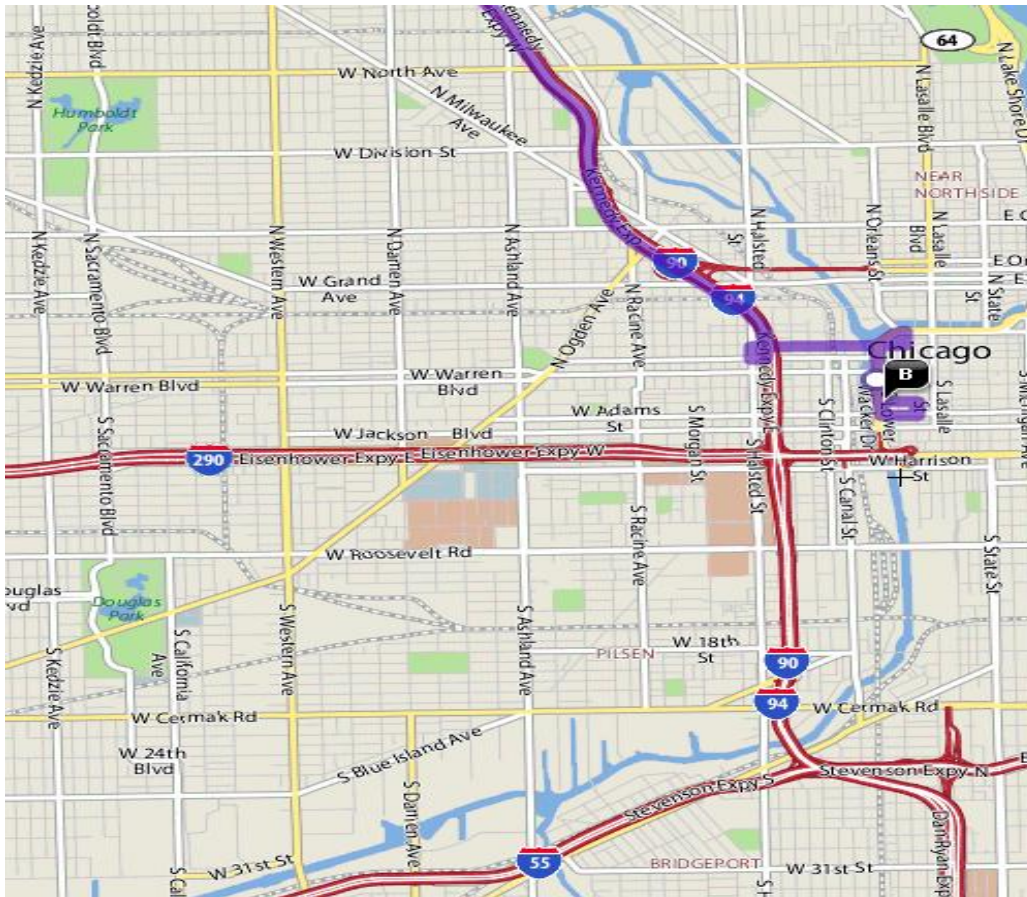

### From the West

I-290 East (Eisenhower Expressway), continue on West Congress Parkway.  
Take the Wacker Driver/Franklin Street Exit onto the South **UPPER** Wacker Drive.

### From the North

I-90 East toward Chicago, take exit #51E/Monroe Street, turn left on Monroe 0.5miles,  
turn right on South **UPPER** Wacker Drive, make a U-Turn on South **UPPER** Wacker Drive.

### From the South

I-90 West toward Ryan Expressway/Wisconsin/I-94 West, take exit #51D/Madison Street,  
turn right on West Madison Street, turn right on South DesPlaines Street, turn left on Monroe Street  
0.4 miles, turn right on **UPPER** Wacker Drive.
